
Speaking of home ownership, there is a little difference between buying a home listed on the National Register of Historic Places and one that has been named a Local Landmark. It has come to our attention that realtors and others don't know about this "little difference," which makes ALL the difference as to what can and can't be changed about a home. If a home has been named to the NRHP, and many of the homes located within our NRHP neighborhood are so designated, owners have no obligation to open their properties to the public, to restore them or even to maintain them if they choose not to do so, and exterior alterations are not restricted if a federal license, permit or funding is not involved.* BUT, if a home has been named a Local Landmark, the Historic Preservation Commission of the City of Council Bluffs has the authority to review any proposed exterior alteration, including remodeling, demolition and new construction which affects the special characteristics of the site. To the best of our knowledge, there are only two homes in Council Bluffs which have been designated a Local Landmark, one being the Historic General Dodge House.

The President's Corner

Those of you who frequently motor passed the Dodge house on 3rd Street may notice that the brick streets have gotten a little less bumpy. The Gibraltar Neighborhood Association, The General Dodge House and the Fairmount Park Neighborhood Association have been working closely with the Council Bluffs Public Works Department, namely Greg Reeder and Matt Cox, on a Council Bluffs Brick Street Initiative.

The pragmatic day-to-day driving conditions of traffic on these streets has always been a concern so we decided to take action and to do something about it. The coalition started to meet back in June to discuss our concerns with the deteriorating state of the few miles of brick streets we have left within Council Bluffs. From the neighborhood association perspective the brick streets were vital to maintaining our Historical Status on the National Registry of Historical places. This translates directly into tourism dollars generated for events like Railroad Days, of which the Dodge House is a featured stop, and continued economic development for the city.

Partnering with the Public Works department, we've been meeting regularly at the Dodge House so that all groups involved could share their concerns. From the city's perspective there was no clear policy in place specific to maintaining the brick streets. Most of the repair work was performed by utility company sub-contractors or homeowners where no consistent standard was applied. That is why we have the patch work of concrete and asphalt that we see today.

We reviewed previous retention assessments of the brick streets done by the city from the nineteen eighties and whether an existing city ordinance (Chapter 16.03.1105) whose purview is building preservation might also include preserving the brick streets. While drafting and passing policy might be considered the "easy" part the greater, more-difficult concern is to consistently communicate and enforce a policy across all the various entities that do repairs and perform maintenance on the brick streets.

The consensus that all parties were able to reach is when

repairs are done the brick is put back into the street, no concrete patches, no asphalt patches. The City has communicated to their Permits Issue Department that when home-owners, contractors or utility companies apply for permits to perform work that effects any of the existing brick streets, this policy will be applied and enforced. They have also shared this information with all the utility companies within the city at their monthly meetings.

For our part, the neighborhood associations have begun to communicate to our constituency that when performing renovation or repairs to have their contractor confer with the city on the Brick Street Repair and Retention policy so that the job is carried out correctly and there will be no need to issue "work stop" orders.

The results we are seeing is that a few weeks ago the Public Works department piloted a series of small repairs performed by Linhart Construction on 3rd Street by the Dodge House. They took up the bricks, compacted a new paver base and re-inserted the bricks into the street, locking them in with a small grain sand that was brushed over the surface.

While this is just the initial steps in our effort I want to take a moment to thank the Public Works Department for partnering with our various groups to initiate an effort that I firmly believe will have long-lasting results within our immediate neighborhood and our community.

BE ALERT BE SAFE!!

I came across these helpful hints on the web. Because of recent abductions in daylight hours, refresh yourself of these things to do in an emergency situation. This is for you, and for you to share with everyone you know. After reading these 10 crucial tips, share them to someone you care about. It never hurts to be careful in this crazy world we live in.

1. Tip from Tae Kwon Do: The elbow is the strongest point on your body. If you are close enough to use it, do!

The ultimate goal is to have a well-informed preservation community focused on projects that enhance and protect Council Bluffs' historic resources. Signs of Stroke

DO YOU KNOW THE SYMPTOMS

Sometimes symptoms of a stroke are difficult to identify. Unfortunately, the lack of awareness spells disaster. The stroke victim may suffer severe brain damage when people nearby fail to recognize the symptoms. Here are three easy questions to ask:

S: Ask the person to SMILE.

T: Ask the person to TALK and speak a simple sentence coherently.

R: Ask the person to RAISE both arms.

And here is a new sign of a stroke:

Ask the person to STICK OUT HIS/HER TONGUE. If the tongue is crooked (goes to one side or the other), this is also a sign of a Stroke.

If the person has trouble with ANY ONE of these tasks, call 911 immediately!!


