THE FUNDRAISING TRAIN HAS LEFT THE STATION

FPNA has just learned the good news that we have been awarded \$5,000 from the Pottawattamie County Community Foundation (PCCF) for our next round of identification poles. Yay!!! This means that work has to begin to complete this second phase of our poles project, not only the ordering of poles and other stuff and putting our installation crew to work, but (here it comes) getting down to the serious business of finding the rest of the money to make this all happen.

In the August newsletter, we laid it all out—what we already have and what we need. We explained that, in addition to the \$5,000 grant, we must spend \$2,500 of FPNA funds and find an additional \$2,500 from other sources. These poles are expensive and five of them, along with all the extras like concrete, cost upwards of \$10,000. We can do it, though, and it is worth it because we all agree that these poles are a quality product that will enhance our neighborhood for decades.

Many of us have paid our dues or joined the FPNA for the first time (the most recent ones named below), and many more of us have made donations (again, named below). Our donation total to date, including not only money already received but also pledges for future contributions, is \$1,775. All this has come from private individuals—we haven't even begun our campaign in the public sector yet! Thanks to all! 

The series is being sponsored by a coalition made up of the Iowa Newspaper Foundation, the Iowa Freedom of Information Council and the National Freedom of Information Coalition. The Council Bluffs meeting will be hosted by The Daily Nonpareil.

According to The Nonpareil's publisher, Tom Schmitt, the series is a new idea and is aimed at helping the average citizen understand their rights and be better prepared to deal with local government entities.

Attendees will receive a "toolkit for democracy" complete with resource material. The toolkit will include the latest edition of the Open Meetings, Open Records Handbook; information about the newly-formed Iowa Public Information Board; contact information for national, state and local officials and resource offices; tips for attending open meetings; tips for obtaining public records; voter registration forms; and sample public notice request letters.

SAVE MONEY= SAVE ENERGY

Lighting is critical for comfort and security, but it can account for up to 15 percent of your annual electricity costs, according to the U.S. Department of Energy. Reducing lighting energy use is one of the fastest and most effective ways to lower your utility bill. There are a number of things you can do to improve the energy performance of your home lighting, including the following:

Turn off lights in any room you are not using and throughout the house when no one is home.

Instead of lighting an entire room, focus low-power light where you need it (task lighting). For example, try using a portable lamp for your home office, or use under cabinet lighting in your kitchen.

Use high-efficiency fluorescent tube lights in garages, work rooms and laundry rooms.

Carefully clean light bulbs and fixtures regularly to maximize light output.

Take advantage of natural light during the day by opening blinds, shades and other window coverings.

Use three-way lamps; they make it easy to save energy by reducing light levels when bright light is not needed.

Install dimmer switches; reducing the intensity of light in a room saves energy. However, make sure the dimmer is compatible with the lamp it is controlling.

Replace low-efficiency incandescent bulbs with Energy Star qualified compact fluorescent lamps (CFLs). They use less energy and last up to 10 times longer.

Use high-performance, light-emitting diode (LED) lamps for decorative lighting, holiday lighting and under kitchen cabinets.

New LED lamps are available in general purpose (Omnidirectional) and directional (recessed cans, spot and track lighting) offering superior light quality and energy savings. Put the right LED lamp in the right socket.

Think lumens not watts

When shopping for light bulbs, think lumens not watts. Lumens measure the light output of a bulb, while watts measure the amount of energy they use. For decades, consumers have purchased bulbs based on watts. In today's lighting market—with a variety of energy-efficient lighting products available—it is more economical to compare lumens rather than watts.

DOG DOO, WE'VE ALL STEPPED IN IT

Our neighborhood is a welcoming place for dogs, either the homegrown ones or visitors from around the area who seem to enjoy walking our streets. We are good neighbors and are polite and friendly to these dogs and their human owners. We want this "good neighbor policy" to continue but when we step in the unwanted deposits left behind by inconsiderate owners, our good will is hard to maintain. Therefore, we wish to call to the attention of all dog owners that there are two City ordinances that apply to you. City ordinance 4.20.140.b prohibits allowing a dog to deposit feces on property other than that of the owner without picking it up. City ordinance 4.20.140.h requires owners to pick up feces deposited by their dog on their property at least once every 24 hours. Failure to comply with these ordinances carries a fine of \$750 plus \$85 court costs for the first offense. The fine jumps to \$1,000 for the second offense. Come on people! Picking up dog doo is easy and could save you some serious money.


Italian Chicken Skillet by Kyle Muschall 332 Glen Avenue

1 tablespoon olive oil	1 (28 ounce) can Italian-style diced
4 skinless, boneless chicken breast halves,	tomatoes
cubed	8 ounces small seashell pasta
2 cloves garlic, chopped, or to taste	5 ounces fresh spinach, chopped
1/2 cup red cooking wine	1 cup shredded mozzarella cheese

- -Heat the olive oil in a large skillet with a lid over medium heat, and cook and stir the chicken and garlic until the chicken is no longer pink in the center, 5 to 8 minutes.
- -Pour the wine and diced tomatoes with their juice into the skillet, and bring to a boil over high heat while scraping any browned bits of food off of the bottom of the pan with a wooden spoon.
- -Stir in the shell pasta, and return to a boil.
- -Cook uncovered, stirring occasionally, until the shells have cooked through, but are still firm to the bite, about 10 minutes.
- -Spread the spinach over the top of the pasta, cover, and simmer until the spinach leaves are cooked, about 5 minutes.
- -Sprinkle the mozzarella cheese evenly over the skillet, and simmer until the cheese has melted and the pasta is bubbling, about 5 minutes.
