Trails: Phase One would establish 1,200 feet of wood chipped trails. These trails are designed to engage the public with the restored woodland and provide improved pedestrian access to adjacent neighborhoods.

Water Playground and Plaza: An essential element in making Return to Fairmount Park successful is to return families and children to this unique and historic park. The keystone of Phase One will be the development of a water playground and adjacent plaza. Water playgrounds, sometimes called splash pads, are extremely popular.

This will be the first such facility in Council Bluffs. Water playgrounds attract children and their parents. In face, a major concern in locating one in this park was a location where a large number of parking stalls were available. The area chosen has adequate existing parking already in place.

November 20, 2014

The centerpiece of the water playground and the plaza will be a series of monuments. These elements will acknowledge the Rotary of Council Bluffs as the Woodland Restoration: Fairmount Park's historic Oak lead donor of the water playground/plaza and provide information regarding the Rotary Club's history. Another monument will discuss the history of the park. Donor names will also be noted on these monuments.
