
LOOKOUT POINT CLEAN-UP

QUEEN ANNE EĈCENTRICITY

200 Park Avenue

The reign of Queen Anne (1702-1714) was long over by the time the fanciful "painted lady" houses, full of gingerbread and turrets, borrowed her name for this style of architecture. More than 150 years after the good Queen's death, her name was wrongly attached to an ornamental style of furniture because it was thought that it reflected the popular styles during her lifetime. Thus, a similarly eccentric, ornamental style of architecture that began in the 1870s also erroneously became forever known as Queen Anne. The picturesque, anythinggoes style flowed from England to America courtesy of an influential book, and from 1880 to 1900 it was the dominant home style in the U.S.

The Machine Age made possible this clearly Victorian style. Suddenly, details such as spindles, turned porch posts, and gingerbread trim could be factory-made and shipped all over the U.S. via the railroad. The Queen Anne style spawned many variants, as can easily be seen in our own streets: Stick, Eastlake, Shingle, Victorian Gothic, and second Empire. This can make it a daunting task to identify a Queen Anne from other styles, but they do share many attributes, such as asymmetrical facades, large front-facing gables, broad front porches, steeply pitched roofs, and, of course, all that gingerbread that is often present.

The basic tenet of Queen Anne architecture is to mix styles. This conglomeration of influences produced buildings that can often be easily recognizable as pure Queen Anne. While our own Historic District features more than 21 examples of this style, the most easily identified homes are at 109 Park, 126 Park, 164 Park, 405 Park, 136 Glen, 148 Glen, and 420 Glen.

Because this style of architecture fell out of favor in the early 20th century, it can only be found on the two oldest streets in our neighborhood. For all the others, that's a different story that may be written one day—just not today.

FPNA BOARD MEETING MINUTES JANUARY 2015

The newly elected FPNA Board of Directors met on January 24, 2015, immediately following the adjournment of the FPNA Annual Meeting. First order of business was to elect new officers and name others to appointed positions. Results are:

President: Sharon Babbitt Vice President: Michelle Mutchler-Burns Secretary: Kelli Deere Treasurer: Dave Huggins Special Representative: Kyle Muschall Publisher: Kyle Muschall Editor: Sharon Babbitt

The following topics were discussed:

- Method for distribution of newsletters—agreed to purchase four holders with stakes to be installed at the present locations of the poles near the empty lot at 401 Park, the KOIL building on Huntington, and the corner of High School and Glen. They will contain printed copies of newsletters, and will be updated as needed. If this method is successful, more holders with stakes will be purchased. Treasurer to purchase these. Sixty copies of newsletter will be divided among these locations. Newsletters will no longer be hand delivered to individual homes.
- A lengthy discussion was had about the neighborhood signs, which were installed in the front yards of historic homes in the neighborhood. As many of these signs have not weathered well, it was decided that 2015 will be the year to begin the needed repairs. Dave Huggins will compile a budget so that we can know the costs involved.
- Yard of the Month awards will begin with the month of May and will continue through August. Kelli Deere will coordinate this program.
- The neighborhood wide garage sales will continue to be held bi-annually, with the next one set for 2016.
- Terri Dowell gave a report on the Laundry Love program sponsored by Promise Partners, which will take place on April 16th. No decision was made as to whether or not FPNA will again participate in this charitable activity.
- The regional conference of Neighborhoods USA will be held on October 3rd. FPNA representatives may attend.
- Greg Meyers will represent the FPNA in the City's effort to improve the holiday lights in downtown. Mayor Matt Walsh and City Councilman Nate Watson are spearheading this effort.
- Mark Hansen will be asked to ressurect our Facebook page and include links to the FPNA website. This will include electronic versions of our newsletters.
- Shari Hansen will host the next FPNA membership meeting at her home on April 11th. Notification will appear in appropriate newsletters.



With Publishers Clearing House the only thing I have received from them is always in the mail. Never give any information over the phone.

Also I have heard that a lawyer will call and tell you your grandchild is in jail and you need to wire money so he/she can get out of jail. This is a scam as well and they just want you to wire money.

If this happens ask for the facility where your grandchild is being held and call them directly. At our facility, if someone is taken to jail they can have several phone calls. If your loved one does need your help, they would contact you personally.
