



The big news right now is that the City Council **L** approved our request to use one if the vacant lots on upper Park for our pollination garden. Here's how it came about, step-by-step:

Our idea took root (pun intended) at the January membership meeting and board meeting to follow. Several people volunteered to be on the committee and Michelle was named as the chair. Research began on what bees, butterflies and hummingbirds need to begin their job of pollination and general living. A supplier was found for wildflower seeds and a contractor was contacted about tilling. We got permission from nearby neighbor Lucille Dunlavy to use her outside water hydrant and we were so glad of this that we named her as an honorary member of our committee. So far so good.

We found out we had to have City Council permission and this meant a detailed application package. We got that done and it was good enough to gain approval from the Community Development Department. We then appeared in person before the City Council, where Sharon, Michelle, and Marie presented our application. It was approved unanimously and a lot of interest was shown by people after the meeting—about wanting such a project in their own neighborhoods. Hooray, maybe it could go Citywide!

So, now we're on our way, right? Wrong. We ordered the seeds but it is still not clear where we have to go to pick them up—Council Bluffs, Ankeny? We are determined not to have to pay retail. Then the tilling contractor has been so busy he has not even been able to name a date for his work to start, and we can't begin without him. This is a larger area than a home garden tiller can do, as you can imagine.

Here we are, in limbo, and Summer will arrive shortly. If we don't begin our project soon, it will be too late to capture the spring cool and rainy weather. We may have to wait till Fall. This won't be all bad, as Fall is a dandy time to plant as well. There is one thing for certain. After all this, our project will get done!!!

A POLLINATION OF EFITS GARDENII

we may appreciate it, but bee and other pollinators are vital to the U.S. economy and our sustainability as **L** a nation. The USDA reports that bee pollination is responsible for more than \$15 billion in increased crop values per year and that one in three mouthfuls of our diet benefits from honeybee pollination. But, while our demand for pollinated food sources continues to increase, since 1940 our honeybee population has decreased from 5 million to 2.5 million. Since 2006 the annual loss of bee populations has averaged a frightening 33% each winter.

Scientists have been unable to pinpoint a single reason for the decline in bee populations and actually suspect multiple reasons. The four most likely causes are pathogens, parasites, lack of nutritional diversity and low nutritional value of pollen available (the types of crops and flowers planted are not varied enough and hybrids lack good pollen), and pesticides.

While this may seem like an overwhelming problem, there are simple things ordinary citizens like us can do to help rebuild our bee population, such as incorporating pollinator-friendly plants into our yards and avoiding use of pesticides. (If pesticides must be used, avoid applying them during the mid-day hours when bees are foraging pollen from flowering plants.)

You can also assist by volunteering your time to water, mow or weed our neighborhood pollination garden. Other benefits of the pollination garden include neighborhood beautification, producing more breathable oxygen and reduction of CO2, establishing root systems that purify water and prevent erosion, and spending more time with your neighbors and friends in the sunshine.
