The President's Corner

ere's more on the ongoing subject of the pollination garden. It is proving to be harder to accomplish than we thought it would be. Changes to our plans are happening every time we turn around, and resolution seems always to be just around the corner, and yet not.

We haven't given up on planting any of those vacant lots in the 400 block of Park. They remain a scar on our landscape and are begging for wildflowers. Keep in mind that anything you read here doesn't preclude us from continuing to pursue this goal, although we may have to postpone it. This is a vague statement and any and all presidents at any level reserve the right to be vague!

After receiving a very high estimate for professional tilling, and determining that our volunteers should not, and will not, be asked to take on this task, we put the 400 block lots on the back burner.

At the recent picnic, a suggestion was made to find smaller and more manageable locations around the neighborhood for our pollination goals. Our committee toured the neighborhood this past week in search of such locations. Many were found but all were on private property and require owner permission. We have that permission from two homeowners, so far We determined that we would scale down our planting goal for this fall to a manageable level and stick with one of these locations. They will require either some tilling on the flat location, or the building of a raised bed to accommodate the steep slope involved on the other one.

We've estimated that the building of a raised bed would cost about \$200, while the volunteer who said he would do the tilling hasn't yet gotten the price for the rental of the equipment. Either cost would probably be approximately the same. The seeds have already been bought and paid for; they are resting in a cold location and will remain viable for as long as it takes to resolve this immediate issue.

So, how long will it take us to resolve this issue long term, you ask? Your guess is as good as mine but let's just say—it takes as long as it takes.

YOU & YOUR YARD WASTE

s we move into the end of summer, the leaves begin to fall, and you may have more yard waste to set at your curb. Here are some tips and reminders for your yard waste.

Remember to <u>always</u> separate trash from yard waste. These items are collected separately by RR Waste Solutions, the City's waste hauler. If yard waste is not separate, it will be tagged and not collected.

On your curb, place your yard waste a few feet away from trash, so waste haulers recognize where one ends and the other begins.

Yard waste may be placed in a regular garbage can, City-approved Poly-cart or paper yard waste bags. Mark containers with a "Y" or place an orange yard waste sticker on each can.

Gather limbs and branches into bundles no more than 4' in length, 2' in diameter and 60 pounds in weight.

Tie yard waste bundles with string or twine.

Yard waste is unlimited through November 30.

Pumpkins, corn stalks and other garden waste can be placed with yard waste.





YARD OF THE MONTH FOR JULY & AUGUST

Here are our July and August selections for the final awards in 2016's series of YOMs. These selections were made some weeks ago, when things still appeared in summer dress.

Our YOM for July is 232 Park Ave., homeowners Sarah and Chris Ebke. A combination of old brick and landscape blocks comprise the borders surrounding the porch and sidewalk of this Queen Anne Victorian home. The bayberry bushes are beginning to show a touch of red, while the boxwoods will remain green all season. Stella d'Oro daylillies, hostas and other perennial flowers add more color.

Our YOM for August is 321 Park Ave., homeowners Sharon and Mark Peters. The focal point of this yard is the large teal colored container filled with cascading plants and flowers. The color of this container coordinates with the unusual teal of the welcoming front door. Ornamental grasses and bushes complete the look. The old and magnificent maple tree near the street overlooks this and other homes nearby; if trees could talk this one might tell stories of the history of our entire neighborhood.

BOW HUNTING

Bow hunting for deer begins at dawn on September 17th and continues through next January. Why do we care? One of the prime areas for hunting is Fairmount Park and two hunters licensed to hunt deer have been assigned there. The legal time is ½ hour before sunrise to ½ hour after sunset. Turkey hunting runs during the same period. Last year, hunting in Fairmount Park was banned because of Park renovations, but residents are advised to be aware of the activity this time around. Although bow hunting is permitted in neighborhoods zoned R-2 and R-3 (that's us), it is restricted to large properties of at least three acres. There are no properties that large in our densely populated neighborhood, so this should not be an issue.
