## GENERIC DRUGS WHAT YOU SHOULD KNOW

The USDA has strick guidelines for generics. In order to be considered equivalent to its brand-name counterpart, it must:

Contain the same active ingredients as the innovator drug

Be identical in strength, dosage form and route of administration

Have the same use indications

Be manufactured under the same strict standards as FDA's requirement for innovator products.

Here are some common questions about generics:

Are generics as good as brand-name drugs? Yes.

How do you know when to use them? Go with generics because of cost savings. Some health plans actually mandate the switch from brand name whenever possible.


Which are safer—brand names or generics? **No difference.** 

Is the approval process for generics the same as brand names? Simpler because generics don't have to repeat all the clinical trials.

If you have a question about using a branded drug instead of a generic, talk to your pharmacist, who can help you decide if switching to a generic is a good idea in your particular case. If you believe your generic is not working correctly, talk to you doctor about switching back. The majority of generics work exactly the same as branded drugs and can save you a lot of money.

## DEATH BY WALLPAPER

rsenic that is the culprit. It was used in the manufacture of wallpapers in 18<sup>th</sup> and 19<sup>th</sup> century England because it achieved the vibrant shade of green that was so popular at the time. This means that arsenic would have been present in most homes despite its adverse effects on health.

During the 1860's, England and France were notorious adversaries in the "war of the wallpaper." France produced luxurious designs on fine linens, while England, in the middle of the Industrial Revolution, changed their technology to provide beautiful designs accessible to the middle class; they ignored the growing evidence of the flaw in their designs—that the arsenic that produced that shade of green so much in demand was also affecting the health of the people who lived with it. What it came down to was commerce. The British Government wanted sales of their manufactured goods to flourish.

Public demand to remove arsenic from their products finally led to the abolishment of the use of this harmful substance in everyday items, such as soaps, medicines, pesticides, rat poison, beer, postage stamps, and more.

As for the wallpaper, it is unlikely that anyone today would possess wallpaper with arsenic in it, so not to worry. Your Great Grandma might not have been so lucky.

We acquired two new members at the recent membership meeting. Thank you to Toni Allen and Ben and Tali Washburn for supporting the FPNA and its goals.


#### POLLINATION GARDEN WEED PARTY


